Overall, it has been a successful year. He thanked the volunteers who made it happen. Rev. Helen Lingham thanked Andrew Halladay for his leadership.

07 – 02 Building Improvement: Flooring: Stuart Allan explained the need for all the flooring in the church building to be replaced. The plan is to do this in phases over three years, beginning with new carpet in the sanctuary in the first year. Total cost will be \$60,000 - \$80,000 (first year \$25-30,000). Two estimates have been received, with a third still to come. There was discussion about whether to paint at the same time.

Vicar's Report

What a year this has been! Last year at this time I had set up some goals for myself as your Vicar, not knowing we would all be challenged by a global pandemic and public health restrictions. My goals for 2020 were 1) to implement regular visioning and planning meetings with Parish Council, 2) to start a community garden on St Andrew's property, and 3) to enhance the St Andrew's worship experience. In some ways, I didn't accomplish any of these goals, though in practice the first and the third were accomplished in unexpected ways.

Parish Council did start to have regular visioning and planning meetings every second month at the beginning of 2020, but, like everything else, parish council had to adapt to an online format. All of our meetings then became about planning for survival rather than exploring the questions of identity and ministry that I'd hoped we would discuss. However, through the pandemic we have explored those questions in unexpected ways. For example, interacting with St Dunstan's has helped us come to some understanding about how we are and how we like things. We are, for example, a more introverted group than they are and maybe have more comfort with silence and reflection. We maybe have a more thoughtful and a quieter spirituality. That said, we've also learned that we like to participate in worship. We like to be engaged in reading scripture, in music, and in the prayers. We are not just observers. And ongoing participation in our bible studies and in the making of prayer shawls means that we continue to practice deepening our faith in community, even though we've been a part.

In terms of enhancing the worship experience, who would have thought that we could so quickly adapt to the online platforms and all of the technological demands that this would make on us! The St Andrew's community has done a remarkable job of learning and participating in Zoom worship. This experience has been challenging and has not been as easy for some of us as for others, but I anticipate that there will be a whole new kind of energy when we are able to meet together again. We have all learned just how much we like and need to be together, and I suspect that very few of us will be taking our church family for granted going into the future.

For the upcoming year, I am setting the following goals for myself.

1) To create and implement and long-term strategy for music.

I am currently setting up music subcommittee made up of all of the members of parish council who are in the choir. These are: Heather Clarke, Lesley Glover, Carl Markwart, and Marsha Miller. The topics we will discuss are: the organ (do we want to repair it, replace it, or remove it), the position of music director (are we happy to continue with a contracted accompanist or do we want to create a position with more responsibility), and the choir as worship leaders (where should the choir sing from, what should they wear, how often should they offer special music). I expect that this group will have a report to offer before Easter.

2) To reconfigure the worship space.

In order to replace the flooring in the church, everything that was bolted to the floor including the communion rails and the pews will need to be unbolted. We are also planning to remove the choir stalls and the platform that the altar is on as it will be more cost effective to put new flooring on just one level. This gives us the opportunity to really wonder about how we want to reconfigure the space once the new flooring is in. Do we want to place the altar more centrally so that we can sit all the way around it? Do we want to continue to be able to kneel when we receive communion? Do we want to make space for projecting the service rather than creating bulletins every week? Where should we put the sound board and how do we make it pretty? There are lots of questions to answer! Helen and I will be putting together a process for discussing some of this at vestry and will then be sending out a survey so that everyone will have the opportunity to let their voice be heard.

3) To explore ways of working together with St Dunstan's.

One of the gifts of this pandemic time has been the opportunity to share in worship with our Anglican family at St Dunstan's church in Aldergrove. Many people have expressed a desire to keep the relationship up and develop it further once we are able to meet and worship in our buildings again. What are the ways that we can work together? We'll certainly want to have some in-person social events. Do we want to continue to hear sermons from the various clergy at both churches? How can we make that happen? Do we want to share staff in other ways? To answer these questions, the wardens and clergy of both churches will meet in Lent to plan for a larger Parish Council joint meeting after Easter. The first meeting will be to create a short list of opportunities and then the second meeting will be to decide which opportunities should take priority.

And finally, we all will have the goal of meeting together in person once everyone is vaccinated and we are able to put the pandemic behind us. I anticipate that we may be able to meet together again in the summer, and that we should plan a grand reopening for September, but these are just guesses. It may be that we will be able to meet together sooner. But we will have to play a lot of that by ear.

In the meantime, I am grateful to serve as your Vicar, and I appreciate all of the ways that you have supported me and my family over the course of this very peculiar year.

- That working together with another Deacon from a neighbouring church could be so rewarding (thank you Linda!).

I'm so thankful for the creativity and possibilities that have opened up, even while so much has been so hard for us this past year. I'm thankful for the two church communities to which I feel strongly connected, and the great leadership that David and Andrew have provided for us all (speaking of creativity!). And, I wonder, where we will go from here...what we will leave behind and take with us, as the journey continues.

Warden's Report

When we held our 2020 Vestry meeting last February, we certainly had no idea what was about to happen. Since then we all have been part of a global pandemic, something not seen in 100 years. We have learned there is no quick solution and we have been adapting to this new way of life. For many of us this has meant that we have been unable to travel and to see friends and family. As we begin our 2nd year of Covid19, we are hopeful that with the vaccine, we will soon see the need for precautions end, but there are likely several more months before things will return to normal.

Last March, St Andrew's and St Dunstan's joined on Sunday mornings for Zoom services. Thanks to the hard work of Rev. David Taylor and Rev. Andrew Halladay, we were able to enjoy interactively getting together for worship. While many churches used video streaming for their services, the use of Zoom allowed participation by all of us. Sharing this difficult time with St Dunstan's congregation has been great.

Attendance on Sunday's Zoom services has been amazing. We even have had people joining us from churches other than St Andrew's and St Dunstan's.

We were also able to hold monthly Parish Council meetings and have regular church executive meetings through Zoom.

In October, we began to hold our 10 am zoom service from the church with some in-person attendance. We alternated between St Dunstan's and St Andrew's for few weeks until the increase in provincial restrictions forced us to go back to just online services.

Throughout the year we continued to receive help from many of you, to keep everything going. We would like to particularly thank Joanie Markwart for her continued excellent work as Parish Administrator, coordinating our services, publishing our weekly newsletter, and answering the many questions you all had. Also thanks to Trevor Barnes for keeping all our web sites in operation and working with Joanie to get the services published, so everyone had access to them.

We also especially would like to thank Rev. Andrew Halliday and Rev David Taylor for their persistence at working with new technology to bring us our weekly services, keeping us "upbeat" and providing us with great leadership.

We would also like to acknowledge the work David Harrison and Larry Amskold did keeping our grounds looking great throughout the year.

We would also like to acknowledge the great work Heather Clarke did coordinating PWRDF and carrying out successful fund-raising campaigns in 2020.

Your Parish Council continued to work well together this past year managing both the administration and planning for St Andrew's. The Wardens would like to give a special thanks to all of this year's Parish Council members; Heather Clarke, Alison Minto, Amanda Ruston, Katie Markwart, Lesley Glover, Rev. Helen Lingham, Rev Andrew Halladay, Bill Hammond, Carl Markwart and in particular Marsha Miller who did a great job once again, keeping track of our meetings as our Parish Council Secretary.

We are once again very thankful for the work Brian Smith did as Treasurer this past year. We would also like to thank Carl Markwart for his continued excellent work as Envelope Secretary and his additional help to Brian Smith with the church books and financial system.

While under this strange and different situation, the church operated smoothly throughout 2020, however without in person attendance and due to the loss of several long-time members, our financial giving did fall. Revenue from donations was \$121,121 down \$9,000 from 2019.

Total revenue was \$151,232 (\$21,000 under budget and \$11,600 less than 2019). Despite the reduced revenue we were able to manage our expenses and pay all our bills, ending up with a \$27,288 operating fund surplus. The biggest contribution to this surplus was that the Diocese paid our clergy salary in May and June and eliminated assessment payments for 5 months. In addition, they contributed \$2,000 towards new technology equipment purchases, enabling us to buy a new computer, video camera, microphone, and projector. The total contribution by the Diocese to St Andrews in 2020 was \$22,275!

With the uncertainty of the year we did not make any payments to our Diocesan loan, which has an outstanding balance of \$46,985. We will return to making payments in 2021 and the Parish Council will determine when it is comfortable to do so. The Diocese does not charge us interest on this loan and has not shown any concern with our repayment plan.

The Building Fund has increased to \$59,000. We do have two major projects to work on in the next couple of years, the replacement of our almost 40-year-old flooring and the 20-year-old roof over the hall and offices. These projects will be expensive and require significant fund raising to complete.

Our stewardship campaign for 2021 resulted in slight decrease in pledges over 2020.

Hopefully 2021 will be a year when we can return to normal. Once the pandemic is behind us, we will be able to get back together for worship and social gatherings. After sharing services with St Dunstan's for over a year, hopefully, we can find new ways to work with them to carry out God's ministry here in Langley.

We would ask each of you to continue to be an active participant in whatever way you can and encourage you to invite friends and family to join you at St. Andrew's.

Thank-you for your help and confidence in both of us this past year and may God bless each of you.

Building Report

This past year we spent \$3,293 on building repairs and maintenance. This included repairs to the roof after a leak developed over the nursery area, repairs and servicing to the fire protection system, fixing some plumbing issues and regular servicing of the heating system.

We continued to monitor the condition of our roof over the hall and offices. Our roofing contractor has estimated that it will need to be replaced in 2021 or 2022. We do not yet have estimate of the cost to do this work but this Spring we will be asking 2 or 3 different roofing contractors to look at the roof and provide us with estimates and timing to repair.

We had planned to begin the replacement of the flooring in the church and hall this past year. With the pandemic and shutdown of the building we delayed any work until things improved and we can safely have contractors working in the building. Our hope is that by the summer of 2021 we will be able to start by replacing the flooring in the church. We still need to decide on the type of flooring and get final cost estimates. It is expected that phase 1 (the Sanctuary) will cost between \$25,000 and \$30,000.

As this work is done, we will also need to be repainting the Sanctuary and finishing the painting in the hallways.

Overall, the church facilities remain in good shape but as the building gets older there will always be items that need to be repaired or replaced.

With this in mind, we will be focusing on increasing donations to the Building Fund in 2021. We ended 2020 with \$59,208 in the Building Fund but will need at least an additional \$25,000 to begin the flooring/painting work, as the roofing repair will likely need to take priority.

In February I attended another full day diocesan PWRDF event on Mapping. This exercise came out of the Truth and Reconciliation Commission and discussed the Doctrine Of Discovery & 'Empty Land' mindset of the colonizers. We were hoping to bring this exercise to the congregation, however Covid has prevented us thus far.

In October I participated in two multifaceted Zoom meetings with PWRDF Staff & Parish Representatives from across Canada.

Projects:

LENT: Erosion prevention through mangrove plantations in Bangladesh. Remember the leafy tree we had at the back of the church? Each leaf represented \$10.00 raised. Unfortunately, Covid-19 partially curtailed this effort, but we were able to send about \$700.00 to help. Thank you.

<u>ADVENT</u>: This 4-week project was done in conjunction with St. Dunstan's congregation. From the World of Gifts brochure "Buy the Whole Farm" - items to assist families &/or communities in five different countries. We raised over \$3,000.00, more than enough for 5 farms. My thanks to Heather Peart for writing the prayers & to Alison Minto for designing & constructing the farmstead to act as a visual reminder. I used several virtual backgrounds while on the zoom services, and pictures were also included in the service slides & in the Newsletters. Thanks to Joanie & Andrew for their help, too!

I would like to express my deep gratitude and thanks to all who have donated to these very worthwhile projects, especially during these uncertain times. Support by ordering Christmas cards and Prayers for PWRDF & their partners are also greatly appreciated. PWRDF staff send their sincere thanks for your support over the years, on-going as well as individual project directed. THANK YOU!

Envelope Secretary Report

During 2020 there were 83 (prior year 95) recorded donors who made donations to our parish. This includes all regular envelope users and all other donations made during the year. Of this total, there were 67 (prior year 73) regular envelope users and pre-authorized debit (PAD) participants.

The 2020 total receipted donations for the year were \$175,591.04 (prior year \$131,823.21), an increase of \$43,767.83 over 2019 and this included all categories. Of particular note, included in the 2020 total is \$45,101 toward the Salihe Refugee Family. If we remove this amount that is in a trust fund so we can compare prior year giving to the current year, the 2020 total is then \$130,190.04 which is a decrease of \$1,333.17.

- Weekly giving \$113,947.54 (prior year \$116,798.71) down \$2,851.17
- Christmas/Easter/Thanksgiving \$4,528.50 (prior year \$3,671.00) up \$857.50
- Donations General \$750.00 (prior year \$2,052.00) down \$1,302.00
- Building Fund was \$8,473.00 (prior year \$2,481.50) up \$5,991.50
- Flow-throughs outreach programmes (PWRDF Regular, PWRDF Buy-the-Farm and Sources Food Bank) totalled \$2,600.00 (prior year \$1,565.00) up \$1,035.00

PAD participants accounted for \$32,668.00 of the total \$175,591.04 (prior year \$29,206.00), an increase of \$3,462.00. We began 2020 with 18 participants and ended 2020 with 20.
